MARKET SUMMARY

Within a 250-mile radius, Sumter residents and businesses have access to Columbia (42 miles), Charleston (106 miles), Charlotte (111 miles), Augusta (126 miles), Fayetteville (133 miles), Greensboro (177 miles), Raleigh (198 miles), Asheville (213 miles), Macon (241 miles), and Atlanta (250 miles).

Among the best communities in the nation for business and career advancement, Sumter offers job opportunities in a numerous and expanding range of industries. Some of the top employer include Tuomey Healthcare System (1,544 jobs), Pilgrim's Pride (2,210 jobs), and Shaw Air Force Base (6,866 jobs). Major units stationed at Shaw Air Force Base include the 20th Operators Group, the 20th Maintenance Group, the Ninth Air Force, and the 6802d Air Support Operations Squadron. Other tenant units include the United States Air Force Central and the Coalition Forces Land Component Command. Shaw Air Force Base has an economic impact of \$1.6 billion.

Sumter is home to a host of historical attractions listed on the National Register of Historic Places, including the Sumter Historic District, Sumter Town Hall Opera House, Singleton's Graveyard, Salem Black River Presbyterian Church, and many others. When it come to sports, the University of South Carolina is in close proximity along with serval golf courses. Shopping is abundant in the area, including the Sumter mall which is home to stores such as JC Penney, Champs Sports, and Foot Locker. The Poinsett State Park is a beautiful place to visit for the weekend and there are many annual festivals such as Porches of Sumter and Oktoberfest on Main.

Sumter is the county seat of Sumter County and is located in the heart of South Carolina. The city is home to 106,508 residents. On January 1st, 1800, the region became known as Sumter District, named for the esteemed General Thomas Sumter. Renowned for his military accomplishments and patriotism, General Sumter was extolled as the "Fighting Gamecock" during the Revolutionary War due to his commitment to the revolutionary cause and his involvement in numerous battles. When the city was finally incorporated in 1845, it was named Sumterville. Later, in 1855, the city's name was officially changed to Sumter, honoring the General and his role in the American Revolutionary War. Although Sumter has plenty local amenities, the residents also have access to major MSA's nearby.
